I agree to indemnify and hold harmless the City of Stayton ("City") from liability for any and all claims, causes, actions, loss, damage or expenses of any kind whatsoever which may be asserted against the City and/or the Applicant or incurred by my agents, contractors, invitees or guests, including attorney's fees and costs, arising out of or resulting from the Applicant's use of the City's facility.

It is agreed that the Applicant shall abide by all federal, state and municipal laws, regulations and code, applying equal opportunity in all respects and prohibiting discrimination of any kind.
